- 1** C/I CONSISTS OF A CORRIDOR AND 500' IN EACH DIRECTION, NORTHERLY AND SOUTHERLY AND 200' IN DEPTH, FROM THE INTERSECTION OF WILDCAT AND WIRE ROAD
- 2** THE AREA KNOWN AS THE OLD DUMP ROAD IS ZONED FOR LIGHT INDUSTRY FROM THE C/I DISTRICT TO THE BOUNDARY LINE OF THE STATE LAND TO A DEPTH OF 200' ON EACH SIDE OF THE ROAD
- 3** C/I IS A CORRIDOR, 1000' LONG FROM THE WESTERLY LINE OF CHARLIE LE DUC'S MARINE BUSINESS WHERE IT ADJOINS THE STATE PARK PROPERTY, EASTERLY ALONG M-123 TO A DEPTH OF 200' ON BOTH SIDES OF M-123
C/R ZONED BEYOND THE 200' DEPTH OF THE C DISTRICT TO THE STATE PARK BOUNDARIES
- 4** FEB 11TH, 1994 EXPLANATION: C/I FROM THE EXISTING NORTH LINE OF LAKEWOOD CABINS SOUTH TO THE SOUTH LOT LINE OF MOORE'S CABINS. THE FIRST 200' DEPTH ON EACH SIDE OF THE ROAD IS C/I
THE AREA FROM THE 200' POINT TO THE SHORE IN THIS AREA IS C/R. ALSO THE C/I DISTRICT EXTENDS WEST ALONG BOTH SIDES OF M-123 TO A DEPTH OF 200' ON EACH SIDE OF THE HIGHWAY TO THE WEST PROPERTY LINE OF THE VILLAGE FABRIC & CRAFT SHOP
- 5** C/I CONSISTS OF A 1000' CORRIDOR, USING THE SILVER CREEK TAVERN AS THE CENTER AND GOING 500' NORTHERLY AND 500' SOUTHERLY TO A DEPTH OF 200' FROM THE RIGHT OF WAY ON BOTH SIDES OF M-123

NOTE: FOR C/R DISTRICTS USED FOR RESIDENTIAL PURPOSE ONLY, SEE ARTICLE 4 SECTION 4.05 A (1994)

RESIDENTIAL DESIGNATES R DISTRICTS AND INCLUDES THE AREA ALONG WIRE ROAD AND ALONG M-123 FROM PARADISE SOUTH TO THE MOUTH OF THE TANGUAMENON RIVER, EXCLUDING THOSE AREAS DESIGNATED COMMERCIAL AND COMMERCIAL/RESIDENTIAL (SEE ZONING MAP) FROM THE LAKESHORE TO POINT 1,600' WEST OF THE WIRE ROAD

OTHER R1 DISTRICTS INCLUDE 1600' ON EITHER SIDE OF THE HIGHWAY M-123 FROM PARADISE WEST TO THE TOWNSHIP LINE AND FROM THE TANGUAMENON RIVER MOUTH TO THE TOWNSHIP LINE, EXCLUDING AREAS DESIGNATED COMMERCIAL, AND COMMERCIAL/RESIDENTIAL (SEE ZONING MAP)
